**INSTRUCTIONS**

- 1 Submit a separate form on each stallion each year
- 2 The report must be postmarked no later than January 15th
  - A. On or before January 15th of each year, the owner of every stallion must make a written report showing the names and registration numbers of all mares exposed to said stallion through December 31st of the previous year.
  - B. The report also shall include all breeding dates or dates of exposure.
  - C. This report shall include all mares serviced whether owned by the owner of the stallion or owned by other parties
  - D. The report must be made on this form provided free of charge by the AMHA
- 3 The owner of the stallion should require a copy of each mares registration certificate in order to facilitate completion of this form.
- 4 Be sure that the last recorded owner of the mare is the person who contracts the breeding to this stallion.
- 5 Give exact date(s) exposed - if more than one service is given mare - make sure and show different dates.
- 6 Note method of breeding by placing the following letters in column
  - A - Artificial Insemination
  - H - Hand
  - P - Pasture
  - T - Transported Semen
  - E - Embryo Transfer
- 7 If pasture exposed - give date the mare was turned into pasture and date she was taken out of pasture
- 8 Mail one copy of breeding report and one copy of confirmation form to AMHA. The confirmation form will be returned to you upon receipt in the AMHA office.
- 9 If report is postmarked after January 15th, include late charge of \$25.00 late filing fee and \$10.00 per mare listed.
- 10 If report not on file before foal is born, DNA testing will be required to parent qualify the foal.

**IMPORTANT**

If a breeding stallion dies during any current year, his stallion report is due WITHIN 30 DAYS FOLLOWING HIS DEATH

After a mare has been exposed or bred, either by hand or pasture breeding, to one stallion, AT LEAST 42 DAYS MUST ELAPSE BEFORE EXPOSING MARE TO A DIFFERENT STALLION

All stallions that breed to five or more mares in a calendar year must be DNA tested before any resulting foals will be eligible for registration. No foals born after December 31, 1994, will be registered until this requirement is met.

All foals born after December 31, 1995 must be DNA tested prior to registration of their off-spring.
